ACTION REQUIRED REQUEST FOR INSURANCE VERIFICATION

The Rhode Island Division of Motor Vehicles (DMV) has implemented the Rhode Island Insurance Verification System (RIIVS) in order to verify automobile liability insurance for vehicles registered in Rhode Island. RIIVS was unable to verify the insurance information for the vehicle below:

Chapters 31-47 and 31-47.4 of the Rhode Island General Laws require that you maintain liability insurance on vehicles registered in Rhode Island. In order to prevent the revocation of your vehicle registration privileges, you must take one of the following actions before the DUE DATE:

- If the vehicle has CURRENT LIABILITY INSURANCE or you OBTAIN LIABILITY INSURANCE, you must contact your insurance company or agent to have your insurance information submitted to RIIVS using the <u>www.RIIVS.com</u> website and the reference number at the top of this letter.
- If liability insurance has been suspended and the vehicle is not being operated on a road (SEASONAL USE, OUT OF SERVICE, or ACTIVE MILITARY RIGL 31-47-15.1 AND 15.2), you must contact your insurance company or agent to have your insurance information submitted to RIIVS using the <u>www.RIIVS.com</u> website and the reference number at the top of this letter.
- If the vehicle has been SOLD, REGISTERED OUT OF STATE, or your PLATES ARE LOST or STOLEN, go online to cancel your registration prior to the Due Date in this letter. Plates can be cancelled at <u>https://www.ri.gov/DMV/cancel_registration</u>
- 4. If you do not wish to obtain liability insurance, Rhode Island law requires that you cancel your registration. Plates can be cancelled online at <u>https://www.ri.gov/DMV/cancel registration</u>. Plates must be cancelled before the Due Date in this letter to avoid revocation.

Failure to respond to this notice by **01/21/2023** will result in the revocation of your vehicle registration. If revoked, you will be charged **\$252.50** (inclusive of technology surcharge) to reinstate your registration privileges. PLEASE NOTE: if your registration is revoked, you will not be able to obtain or renew a Rhode Island driver's license and obtain or renew any and all registrations.
