**Visual Acuity:**

- Two-eyed drivers: Minimum 20/40 with or without glasses (private vehicles).
- One-eyed drivers: Minimum 20/40 in functioning eye and advised to have rear mirror on the side of the blind eye.
- Public/Commercial vehicle drivers: Required to have 20/40 with or without glasses.

**Fields:**

- Two-eyed drivers: Minimum 115 degrees in the horizontal meridians.
- One-eyed drivers: Minimum 40 degrees nasally and 75 degrees temporarily.
- Public/Commercial vehicle drivers: Minimum 40 degrees nasally and 75 degrees temporarily in each eye.

**Color Vision:** Not basis for rejection of license. Inform applicant of handicap.

### Binocular

**Single Vision:** Constant diplopia is cause for rejection.
